This agreement is between Dem Feuerhuas Gun Dogs and _____ (client) For the purpose of training and having trained the client's gun dog. Outlined below are the standard terms applicable to this agreement.

Client agrees to vaccinate or have vaccinated his/her dog for the following canine diseases before placement in Dem Feuerhaus Gun Dog training program. Proof of fulfillment for the vaccination requirement via veterinary documentation is mandatory to this agreement.

Canine Distemper, Canine Parvovirus, Bordatella (kennel cough), and Rabies.

Rattle Snake vaccine not required but STRONGLY RECOMMENDED!

Client agrees to provide monthly heartworm preventive medication. (example: HeartGard)

Client agrees to provide monthly flea, tick, and mosquito preventive medication. (example: NexGard)

Client agrees to cover any and all expenses related to emergency and or routine veterinary visits required for client's dog while under the care of Dem Feuerhaus Gun Dogs.

Client agrees to supply food for their dog.

Client agrees to pay first month at time of drop off. Payments are made at the start of each training month.

Monthly fees do not include birds used for training. Pigeons are \$4 per bird, quail are \$6.50, pheasant are \$16, and ducks are \$22. Training fees are billed once per month on the same day as drop off. Birds will be charged at pickup. All money owed will be paid before client can pick-up their dog. If amount owed is not paid in full at scheduled time of pick-up, client will receive a \$20 boarding charge per day until amount is paid in full. After 30 days of no payment, the dog is considered abandoned and becomes the property of Dem Feuerhaus Gun Dogs. Dem Feuerhaus Gun Dogs has the right to sell the dog to recover any and all costs associated to the training and care of the dog. Any profit made is the property of Dem Feuerhaus Gun Dogs.

****Minimum of 2 months training is required unless discussed previously. Payment is expected and client agrees to comply with payment upon receipt of invoicing. Rates are discussed prior to dropping off your dog with Dem Feuerhaus Gun Dogs and are subject to change.**

Client understands and agrees that training fees are on a "per month" basis. This means that while client's dog is in training the client will be billed for the training month in its entirety AT THE TIME OFF DROPOFF regardless if the dog is taken home for periods of time for whatever reason (except medical reasons). If client wishes to remove his/her dog from the training program at Dem Feuerhaus Gun Dogs before the minimum 2 month requirement, the remaining months must be paid before pick up is allowed.

South Texas brush offers lots of thorns and burrs. If client desires the dog to wear boots, the client will provide them.

If injury, illness, snakebite, or anything related is to occur Dem Feuerhaus Gun Dogs has the right to take the dog to the vet at the expense of the client. Dem Feuerhaus Gun Dogs will not be liable for any vet bills present or future. If death occurs as a result of illness or injury Dem Feuerhaus Gun dogs is not liable for any loss to include replacement of animal.

If client wishes to visit the dog in training, 48 hours of notice is required to schedule a time for client to visit the property.

If any damage to property, facilities, training items, or the like is to occur, the client will be liable for all damages.

RELEASE OF LIABILITY

I, _____, understand and agree that the training, boarding, traveling, and handling of my dog, _____, will expose the dog to various environments and activities that may be dangerous. Having acknowledged the fore mentioned exposure to danger I hereby release and hold harmless Dem Feuerhaus Gun Dogs and any or all of its representatives, affiliates, or the like from any liability as a result of harm to the dog due to, but not limited to, the following:

Prior injuries or illness; injures as a result of training; injuries or illness as a result of natural causes; injuries or illness as a result of traveling in a vehicle or in tow; and / or injures or illness or death as a result of any type of activity usually associated with the training, boarding, transporting, and handling of a live animal.

This document does not exclude Dem Feuerhaus Gun Dogs, its affiliates, or the like from demonstrating and practicing the utmost care for safety of the referenced animal.
